Returning students: Aug. 21-22 are important!

Returners: Financial agreement due Friday

A reminder that the MANDATORY Student Financial Responsibility Agreement (SFRA) is due by this Friday, Aug. 15. It ensures you understand the College's billing process and procedures. If you fail to sign it by the deadline, your Fall 2025 classes will be dropped and you will be unable to move into PCA&D-sponsored housing. You can access the SFRA in several ways:

From MyPCAD:

- 1. Log into MyPCAD at <u>ss.pcad.edu/</u>. If you are locked out or unable to log in, contact the IT Department at <u>it@pcad.edu</u> or call 800-689-0379 ext. 1004.
- 2. Click the Finances tab.
- 3. Select "Student Financial Responsibility Agreement"
- 4. Read the agreement, sign electronically, and click the Save button
- 5. Click the Next button in upper right, and then Finish
- 6. You will receive an email at the email address you entered at sign-in. Print and keep the email for your records.

From Student Portal:

- 1. Navigate to the portal at <u>pcad.edu/student-portal</u>
- 2. Select the Student Financial Responsibility Agreement tile
- 3. Read the agreement, sign electronically, and click the Save button
- 4. Click the Next button in upper right, and then Finish

5. You will receive an email at the email address you entered at sign-in. Print and keep the email for your records.

Important info about your Fall tuition bill

Students, your tuition statement is now available at MyPCAD. Use this link to access it. Your statement will be subject to change due to adjustments in your class schedule, if you opt for student health insurance, housing, a meal block plan, parking, or require materials for your classes. Review your statement for accuracy. If you have questions about financial aid eligibility, scholarships, or grants, contact Vincent Frank, Director of Financial Aid, at finaid@pcad.edu. The first payment for the Fall 2025 semester was due Aug. 1.

PCA&D offers 3- and 5-month payment plans. You can find the details and the necessary form here. Scroll down to "Available Tuition Payment Plans," and click the "Payment Plans" button... or find the form in your MyPCAD account. Student health insurance info for 2025-26

The College is partnered with <u>QM Services (QMS)</u> for a lower-cost student health insurance plan (SHIP). The coverage includes a prescription plan, support for laboratory tests and X-rays, and inpatient and hospitalization coverage. Keep an eye on your student email for QMS information over the next few weeks.

Students and families with qualifying health insurance will be able to opt out of this coverage. The opt-out process initially includes a charge to your College bill that will be removed once you have completed the waiver process. QMS will handle all records through its confidential portal. If your coverage is initially declined through QMS, please reach out to Student Life at studentlife@pcad.edu so they may work with QMS partners to advocate for your health plan.

To opt out, log onto the <u>QMS website</u> to submit proof of insurance. If you're having issues with the website portal, connect with PCA&D's independent student health insurance administrators at <u>university@qmservicesinc.com</u>. The College's Student Life team will be emailing more summer communications that offer an overview of health and wellness resources available to you during the academic year. Call for Art: Environmental trail project

The Little Conestoga Creek Foundation seeks submissions from artists, makers, artisans, and designers to create art in a variety of formats for an outdoor trailside environment. The artworks will be permanently installed along a 3.5-mile Blue Green Connector, an ADA-accessible trail system and environmental restoration project in Lancaster County. The project is expected to be completed in stages between 2025 and 2028. Potential artwork formats include artistic seating, interactive art for play, 2D or 3D art to highlight biodiversity, and stamped concrete. The size of site areas will vary. The person leading submission, in solo or collaborative projects, should live within a 100-mile radius of Lancaster County. **RFQ deadline is Oct. 15.** Submissions should include resume/CV, a letter of interest, and a .pdf of work samples. Registrar's message for returning students

A message from Registrar Hannah Warner for returning students:

The Self Service course registration portal is now closed. While you can't adjust your schedule online, you should still be able to see <u>live information about which classes are running in the fall and if seats are still available in each one ("register" tab, click "traditional courses", and then "section search").</u> From now until the end of the add/drop period next semester, schedule adjustments will be completed through the Registrar's Office. In the event you would like to change your schedule, you may <u>request a schedule change here</u>. By submitting requests through this link, the Registrar's Office can easily track everyone's requests and make notes for each entry we receive. If you need to, you may submit more than one. All changes are made on a first-come, first-served basis. We will do our best to accommodate everyone's requests, based on your degree plans and course availability.

Additionally, there are several classes that have seats available that meet various degree requirements (humanities, general studio electives). There are also sections of the fall foundation level courses (art history, communications, and studio) if there is a course you need to retake next year. If you can't remember or are unsure if you need to retake a fall semester foundation course, you can review your grades in Self Service ("grades" tab, click "unofficial transcript") to see if there are any "F" grades.

Uwill counseling available through the summer
